Personal data processing on HELIO's website

Data protection in Google Analytics

This website uses Google Analytics, a web analytics service provided by Google Inc. (hereinafter "Google"). Google Analytics uses "cookies", which are text files placed on your computer that help analyse how you use the website. Under the authority of the website operator, Google will use this information for the purpose of evaluating your use of the website, compiling reports on website activity and providing the website operator with other services related to website activity and Internet usage. You may refuse the use of cookies by selecting the appropriate settings on your web browser; however please note that if you do this you may not be able to use the full functionality of this website.

Use of share buttons and plugins

Our website uses share buttons and social plugins for the following networks: facebook, pinterest and google+. These buttons and plugins are identified with the relevant logo. When you visit one of our websites with this plugin or share button installed, your browser creates a direct connection to the aforementioned servers. The content of each share button or plugin is transmitted directly to your browser, which integrates the share button or plugin in the website. By integrating a share button and plugin, the network receives the information that you have retrieved the page from our website. Thus, if you are logged in to Facebook or Google+, the networks can assign your visit to the relevant accounts. When interacting with the share buttons or plugins (for example, by clicking on the "Like" button, submitting a comment, etc.), the relevant information is transmitted from your browser directly to the aforementioned networks.
